- Spring Scheduling - Still working to get practice preferences from the managers. After this information is collected, we will look to distribute a schedule as soon as possible.

Dennis will also work with the City of La Mesa to get a couple of days on the books for field maintenance at the Junior Seau Fields.

**President**

- SUP Update- Two weeks Dennis and Jason had a call with City of San Diego staff to check on the status of the Standard Use Permit. The only update that they were able to provide was that the drafted SUP was now with the City Attorney. On the same call, there was discussion about the difference between repairs and improvements. The improvements have to be ADA compliant. We also need to draft our own permit form when we sublease out the fields.
- Insurance - We will need to get some additional insurance to cover projects and liability for work and construction on the site.
- New Conex/Mower - We will need to have this in place as soon as the SUP is approved and signed. The City is open to a grace period for field maintenance until equipment is purchased.
- Field 3/4 update - The City is reluctant to make a decision about field 3 and 4 use. They would like us to work out field use with San Carlos Little League. We believe that the SCLL PUP is expired, so the City should be the point of contact for field use. Jason made a proposal to SCLL regarding field 3 and 4 use - he proposed that Navajo have sole use of field 4 and SCLL have field 3.

Jason had no luck with his request to use field 3 or 4 for evaluations but plans to reach back out to SCLL to see if they have any other field available for use..
